Limited Warranty:

Subject to the limitations and disclaimers set forth below, Synavax, Inc. ("SynavaxTM") warrants that for the Applicable Warranty Period (as defined below), CrystalShieldTM will be free of defects in materials and workmanship and will remain free from the growth of algae, mold, and bacteria which adversely affects the overall visual appearance of the roof as viewed by a person standing on the ground. Notwithstanding any other provision herein, areas of the roof directly under trees and/or tree branches and/or foliage are excluded from this warrant. In the event that the CrystalShieldTM product fails as a result of a defect in materials or workmanship within the Applicable Warranty Period, SynavaxTM will replace, at no charge to the purchaser, the CrystalShieldTM product or part thereof that proves to have such defect. SynavaxTM further warrants that the CrystalShieldTM does not contain any Environmental Protection Agency ("EPA") registered antimicrobials or other "Hazardous Materials" as such term is defined by the EPA.

SynavaxTM's agreement to replace any product found to be defective in materials or workmanship is the purchaser's sole and exclusive remedy for product failure. This remedy may not be deemed to have failed of its essential purpose so long as SynavaxTM is willing and able to replace any such defective product or part. This limited warranty is transferrable.
